## 2023 Boat Storage Agreement - Due April 1st, 2023

The terms for boat Storage Rental are as follows:

- 1) The rental year will begin April 1<sup>st</sup>, 2023 and will run through March 31<sup>st</sup> of the following year.
- 2) The yearly rental fees shall be \$205 (Two hundred five dollars) for covered storage and \$130 (One hundred thirty dollars) for uncovered storage.
  - A. This rental fee covers the rental year and will not be pro-rated for early departure. Boats initially brought to the yard after November 1 will be charged half the rate (\$100 and \$65, respectively).
  - B. Each year's membership dues and rental fee shall be paid in full, prior to occupying the space.
- 3) The Renter agrees not to hold CCSA or the owner of the boat storage property or CCAIG, responsible or liable in any way for any damage, vandalism or theft of any kind on the renter's boat, trailers or other equipment while they are on the boat storage property.
- 4) The Renter agrees not to hold CCSA or the owner of the boat storage property or CCAIG, responsible or liable in any way for any accidents or injuries of any kind to the renter, or any member of the renter's family or party which Renter has brought to the storage property. Renters are responsible for the safety and actions of anyone the Renter brings to the boat storage property.
- 5) **The Renter shall clearly mark the Renter's name on the trailer tongue for Renter notification in case of need by the Boat Storage Committee.**
- 6) **They should attach the annual parking sticker to the trailer tongue as well soon after receipt.**
- 7) For continued storage privileges, any change in ownership of a boat stored in the yard must be approved by the Boatyard Manager and new owners register with the club immediately.

The Renter agrees to the terms of this agreement and any policies or rules set out by CCSA governing the usage of Boat Storage Facility and Membership Agreement.
